The joint effort project between the Illinois Tollway and IDOT is described as the I-294 / I-57 Interchange project. This contract is part of the multi-year project and is located in the Village of Posen and the City of Markham, Cook County, Illinois. It will create access from southbound I-294 to southbound I-57. The scope of work for this contract includes widening and/or reconstructing pavement along I-294 and I-57 with new Ramp M (SB I-294 to SB I-57), Ramp X (SB I-294 to 147th St (IL-83)), and associated drainage improvements. This work will include excavation for storm sewer, drainage structures, pavement construction, retaining walls, and ditch & embankment grading.
